# > ECOWAS & AU

- It is left for administrators to develop good policies and build systems
- We must mitigate the threat to free movement





- In Africa borders are artificial but remained a bitter and lasting legacy left behind by colonial rule.
- How can we implement free movement across our borders without compromising security?
- What are the policies and systems we can put in place that the public will see free movement in Africa as a benefit rather than a threat?
- Are there lessons we can learn from other continents – Schengen Free Area?



#### Free Movement, to which extent?

- Article 13(2) the Universal Declaration of Human Rights (1948) states that "Everyone has the right to leave any country, including his own, and to return to his country".
- This right to emigrate is however not complemented by an internationally recognized right to immigrate.
- Consequently, the decision of whether a person is allowed to enter another/his country is still in the discretion of sovereign Nation States.



#### Free Movement, to which extent? Contd.

- A dominant feature in regional arrangements is the framing of Free Movement Agreements around potential socio-economic gains for citizens or a perceived shared responsibility.
- ECOWAS 90, residency & establishment
- AU will this be like ECOWAS?
- What about 3<sup>rd</sup> country nationals?
- Our ECOWAS leaders directed the implementation of the Schengen type of visa



#### **POLICY:** Learning From The SHENGEN System



- Free Movement in the Region & the Continent most learn from Schengen system.
- The Schengen Information System
- > No physical internal borders.
- Establishment of FRONTEX
- Integrated Border Management Systems
- Biometric
- Common Judicial System
- Cooperation among Member States
- > 3<sup>rd</sup> Country nationals



#### **SYSTEM:** Only Golden Advise

- No special system to be recommended
- Policy for system/equipment must not be vendor or donor driven.
- Governments cannot fund borders 100% BUT must provide the leadership – a safe border is a safe nation.
- Another alternative is PPP, BUT
  - I. Technology transfer
  - 2. Equity in sharing formula
  - 3. Transference
  - 4. Termination period



# Free Movement is at Risk!

- Terrorism
- Protectionism
- Nationalism
- Politic Election
- BUT we must see the bigger picture
- Nigeria growing sentiment against migrants due to security concern.
- If we think global and act local we will welcome good migrants and refugees – we have many abroad.



#### **Other CHALLENGES**

- Attention of African governments is more on Airports at the expense of Land borders.
- Vendors driving policies
- Attention on equipment without building human capacity.
- Lack of integrating local community in border strategy
  - e.g. community border relation and use of available means of patrol and communication.
- Lack of infrastructure road, rail, petrol stations etc along international rout.
- Law enforcement corruption




#### **Sharing Nigerian Experience**

- Control Before Entry Biometric Visa
- Control On Entry, MIDAS Implemented by IOM with the support of Swiss, Japan & Danish governments
- Community Border Patrol.
- Training of Border Patrol Commanders, Officers and Drivers.
- Deployment of over 200 Patrol Vehicles
- Control After Entry Migrant Registration
- Regional approach June 2017 ECOWAS Heads of Immigration Meeting, Tuga Regional Institution & ongoing ECOWAS Conference on Transhumance.
- Integrated Boarder System MIDAS being linked to i24/7, local Suspect Index etc.

# **The Way Forward**

- Member States of ECOWAS or AU must develop joint facilities to make Free Movement secure and useful – common legal system, information, penalties for individuals and states etc.
- Build efficient system rather than machines.
- Integrated Border System connected to API, INTERPOL, Suspect Index, Open Sources Analysis system etc.
- Establishment of Monitoring & Donor Coordination Teams at both ECOWAS & AU
- Involvement of Civil Society in educating populace in the benefit of Free Movement to reduce sentiment against migrants.
- UN agencies and international organization must provide guideline to states.
