

Objectives of the ECOWAS National Biometric Card

- Transit from the manual / Hand written documents to Machine Readable and Biometrics regimes.
- The Biometrics is highly focused on the age- long facial and finger and requires the migrant to pass through an approved border in accordance with the provisos enshrined in the ECOWAS Protocol Texts on the right of entry
- Provide the legitimate traveler in possession of proper documentation the access into Member States in accordance with the ECOWAS Free Movement core principles; Right of Entry, Residence and Establishment.
- Ensure compliance with international Standard in tandem with the ICAO Travelers Identification regime

Objectives of the ECOWAS National Biometric Card Continued

Facilitate passenger clearance at the ECOWAS borders and encourage timely exchanges of relevant data at the joint border posts

- Key into global best practices on management of our common borders by drawing inspiration from relevant texts of the United Nations (UN) Security Council Resolution on safe travels resolution 2178 of 2014 on foreign terrorist fighter fighters 2322 (2016) to address threats poised by terrorist in the ECOWAS Free Movement region.
- To enhance security clearance and ease of data sharing of Cross Border criminal's profile, in accordance with the legislation on data exchanges
- Prevent those seeking to enter Member States territories to commit cross border crime from gaining entry.


IMPLEMENTATION of the ENBIC

The role of ENBIC in enhancing regional Border Security

Establishment of Joint Task Force and border patrol Establishment of an information "clearing house"

Develop joint training programs on border security matters. Training is critical to effective cooperation & coordination between border security agencies

Clear definition of tasks & responsibilities to minimize overlaps of tasks

Build electronic data sharing links to create a collaborative environment for security agencies to share real-time information for security & compilation of statistics.
