Identity 360: A Multi-Perspective View on Identity

Objective

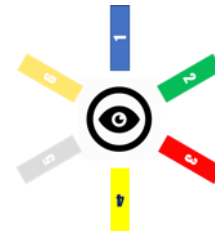
The 6th Annual Meeting of the ID4Africa Movement (ID4Africa 2020) reinforces the collective knowledge gained through the 5 prior meetings, while breaking new grounds through an exceptional program that aims to:

- Characterize, in actionable terms, what constitutes robust, responsible and performant identity ecosystems in an era where legal and digital identity are converging to create new opportunities for inclusive development, service delivery and humanitarian action.
- Identify and address the new issues and consequences that pose threats for ID systems or their responsible use.

The Theme

The ecosystems will be examined from multiple set of views-- economical, legal, societal, institutional and rights-based, and from the perspective of all the actors that are involved. These include the governments that launch them, the civil society actors that monitor them, the agencies that fund them, the private sector that develops and sustains them, and the service providers that use them to deliver benefits to the end-users. ID4Africa 2020 will track the viewpoints of six principal stakeholder groups through an informational icon in each session which indicates the dominant viewpoints expected in the session, using the following color code:

1. Identity providers.
2. Service providers (public or private).
3. Industry (technology, & solution providers).
4. Development & Finance (MOF, Development Agencies, Donors).
5. Governance bodies (legislators & regulatory authorities).
6. Civil society (rights groups, media, & academics).



These six groups represent the stakeholders that need to collaborate to build trustworthy, performant identity platforms that are accountable and capable of empowering the individual end users to exercise their rights and to receive the services they need to function in a modern society.

Program Development Process

The road to the final program is an iterative process and it begins with the release of this program outline which makes reference to a series of thematic track and session concept notes. These are used to solicit responsive content from the Identity Community at large. The outline contained herein was constructed based on the demand identified through ID4Africa research across all of its channels (Annual Meeting 2019, surveys, the ID4Africa Identity Council, direct data gathering and consultation, etc). This document is used to identify quality content and to recruit expertise (supply side) - through the Call for Speakers launched on 15 October 2019 and through direct invitations. The program structure may continue to evolve to match available high quality content and knowledge in the community around the most pertinent topics for the 2020 campaign.

Note about the program development process

- Process is iterative which leads to rapid changes in concept notes. Please keep visiting this page for updates.
- While we can only run 16 InFocus sessions, we may at any point offer more than 16 concept notes, as a result of the crowd sourcing process. Ultimately the supply will determine which 16 InFocus sessions have the highest quality content and hence will survive as the sessions.

They can also be visionary presentations that orient the Identity Community towards promising directions.
DAY 2: JUNE 3, 2020			Thematic Sessions
<p>InFocus (InF): Advanced sessions where a topic is addressed in-depth through a series of presentations by frontline experts or an in-depth panel discussion. The goal of each session is to create awareness and impart practical knowledge around its theme that is pertinent to the African context for 2020. Typically, an InF session will have 4 presentations or 4 participants on a panel moderated by an expert on the matter. The InFocus sessions are grouped into four Thematic Tracks which will be explored from a multi-perspective viewpoint as explained above.</p>

Explanation of the Thematic Tracks

The following table should be used as a guide by potential speakers to decide which Thematic Track their contribution fits best. While it is intended to provide clarity on the unique direction of each thematic, it will be modified iteratively as we crowd source the presentations. We encourage potential speakers to bring to our attention topics and case studies pertinent to the tracks even if they are not explicitly mentioned in the narrative below.

Track	Explanation
<p>DIGITAL IDENTITY AND SERVICE</p>	<p>Explores the landscape of digital identity and its potential for creating more efficient governments (public services) as well as for driving economic growth through innovation in service delivery. The session also explores the role of the private sector, and in particular the consumer brands, and the mechanisms for partnering with the public sector in order to realize national digital transformation strategies that are attracting significant interest across the continent. <i>See Concept Note.</i></p>
<p>OPEN CHALLENGES</p>	<p>Consists of 4 sessions dedicated to major open challenges that will be dealt with in depth:</p> <ol style="list-style-type: none"> 1. Pathways to Legal Identity (InF2): the session will explore the different notions of identity and why legal identity may remain relevant in an increasingly service oriented world. <i>See Corresponding Concept Note.</i> 2. Gender Equity in ID Systems (InF6): The Panel will explore the impact of ID system policy on women and ways to avoid exclusion risks. It will feature a lineup of experts from international organizations as well as government agencies that have first-hand experience with inclusion and exclusion issues within ID systems, specifically when dealing with women. <i>See Corresponding Concept Note.</i> 3. Humanitarian Action (InF10): This session focuses on the range of recent experiences where identity systems have proven to be effective for dealing with human crisis, or long-term problems with humanitarian dimensions—such as refugees, statelessness, natural disasters. It also addresses the challenges of identity management encountered in the context of humanitarian action. The session is presented in collaboration with UNHCR. <i>See Corresponding Concept Note.</i> 4. Interoperability, Security and Trust Frameworks (InF14): This session will explore the ingredients that give ID systems the interoperable trust they need by presenting two recent leading trust frameworks (eIDAS, Pan Canadian Trust Frameworks), and the long experience the worldwide identity community has had with interoperability of trust illustrated by the travel documents (led by the success of the ePassport as a universal interoperable ID document). It will also share the experience of an African Country with the implementation of digital signatures and PKI in the context of national digital transformation strategies. <i>See Corresponding Concept Note.</i>
<p>THE IDENTITY TOOLBOX</p>	<p>Provides best practices and latest developments—policy, technical, business practices—around key capabilities that must be in place and deployed by any identity system irrespective of the application or sector. In totality it is expected to cover advances in enrollment and onboarding, authentication, biometrics, mobile, cloud platforms, machine learning, artificial intelligence, PKI, plus document and data security. Experiences from border management, elections, health, education, civil registration, passports and visas, among others may be presented as examples to illustrate the power of the core capabilities advancements.</p> <p>This track was developed in response to a huge demand from African identity stakeholders seeking actionable knowledge. A must attend track with highest quality expertise!</p>
